## PROGRESS REPORTS

### Report by the IPCC Chair and Vice-Chairs

At the 61st session of IPCC in July 2024, a delegate proposed that the Chair's progress Report to Plenary could identify progress against the three main themes identified by the Chair for AR7: interdisciplinarity; inclusivity; and policy relevance. This approach is adopted in the Progress Report to the Plenary. There is a short narrative briefing for these three themes, followed by lists of Chair and Vice-Chair activities as in previous reports to the Bureau.

#### **Interdisciplinarity**

##### *Internal to IPCC*

Much of the responsibility lies with the Working Groups and their Bureaux. The Working Groups have collaborated to: a) organise the scoping meeting for the Special Report on Climate Change and Cities; b) organise the scoping meeting for the AR& report; and c) select authors for the Special Report on Climate Change and Cities. The Chair has been invited to attend regular Co-Chair meetings and has actively supported collaborative activities.

The Chair has now visited Co-chairs and Technical Support Units for Working Groups I, II and III as well as the TFI, encouraging collaboration.

##### *External to IPCC*

The IPCC Vice-Chairs have been assigned liaison roles with other UN environmental assessments. These are: Vice-Chair Pichs-Madruga (IPBES/GEO7/UNCCD); Vice-Chair Ürge-Vorsatz (International Resources Panel/UNEP GAP report); Vice-Chair Chang'a (World Climate Research Programme/CMIP/WMO United in Science). Vice-Chair Pichs-Madruga attended COP 16 of the UN Convention on Biodiversity. The Chair recently met with the Chair of IPBES to discuss practical collaboration and preparations for IPBES Plenary 11, 10-16 December 2024. The Chair also participated in hybrid meetings convened in the UK concerning plans for a new Panel on Chemicals, Waste and Prevention of Pollution.

#### **Inclusivity**

A variety of initiatives are under way, many following within the remit of the Working Groups. Diversity and inclusion has been actively considered in selecting participants in scoping meetings and author selection. Participation statistics reported elsewhere show considerable progress in terms of improving the balance of participation in terms of gender and developed/ developing countries as well as cross-regional and intra-regional aspects.

Arrangements for an Expert Meeting on diversity, equity, inclusion, and gender-related issues are now almost complete, including government financial support for expanded participation. The Chair will bring forward a proposal for a Workshop on New and Expanded Methods of Assessment to the 62nd plenary which will have the inclusion of Indigenous Knowledge within its scope.

The IPCC Chair, the Chair of the Board of Trustees for the Scholarship Fund, and the Secretariat have been pursuing the mobilisation of resources to support developing country chapter scientists during the seventh cycle.

#### **Policy Relevance**

IPCC, Bureau members and scientists associated with the IPCC have continued to communicate findings to policymakers and stakeholders both internationally and at national and regional levels. Examples of engagement at COP 29 include: a briefing for the UN Secretary General; speeches at the High-level Segment, the High-Level Ministerial on pre-2030 Ambition, the opening of SBSTA,

Earth Information Day and the African Ministerial Conference on the Environment. A group of IPCC Bureau members and AR6 authors briefed members of the International Court of Justice in on findings relevant to the Advisory Opinion on the Obligation of States in respect of Climate Change requested by the UN Assembly.

Several meetings with the major constituencies recognised by the UNFCCC took place at COP 29. These included: the Business and Industry NGOs (BINGOs); the Environmental NGOs (ENGOS); Trade Union NGOs (TUNGOS); Farmers Constituencies, Children and Youth Activists (YOUNGOS).

The Chair led a small team of current Bureau members and former IPCC authors who engaged with the International Court of Justice in the context of their Advisory Opinion on the Obligations of States in respect of Climate Change in November 2024. The purpose of the briefing was to provide background and explanation for approved IPCC material. Only approved material may be cited by the ICJ in delivering its Opinion.
