WORKPLAN OF THE IPCC SEVENTH ASSESSMENT REPORT (AR7)

1. Outcome of the IPCC-62

At its 62nd Session (IPCC-62), the Panel considered the outline and the work plan for the three Working Groups' contributions to the AR7, in line with IPCC procedures which state that, based on the report of the scoping meeting, the Panel will agree on the Assessment Reports' scope, outline, and the, including schedule and budget¹.

At its 62nd Session, while the Panel agreed on the outlines of the Working Groups' contributions to the AR7, the Panel did not reach consensus on the respective timelines of the Working Group contributions to the AR7.

Through the decision (<u>IPCC-LXII-8</u>), the Panel agreed on the outlines of the three Working Group's contributions to the AR7. It also agreed to invite the Working Groups to start their work as indicated in the 2025 budget by initiating the call for nominations for the authors and convening the First Lead Author meeting (LAM1) in 2025. Furthermore, it agreed to defer further consideration of the workplan, including the proposed Implementation Plan for preparing the Working Group contributions to the AR7, to the 63rd Session of the IPCC (IPCC-63).

2. Matters for consideration at the IPCC-63

At IPCC-63 the Panel will consider the workplan of the three Working Group contributions to the AR7, which consists of the schedule and respective budget. The schedules for each of the Working Groups in the following tables show dates for key milestones in 2026, and list milestones for 2027 onwards. The date of one Lead Author Meeting in 2026 has been agreed with a host government, while the dates of others, marked with an asterisk, are approximate and subject to discussion with potential hosts.
