## IPCC media accreditation FAQs – February 2023

### Where can I learn about press accreditation for IPCC meetings?

Details about IPCC press accreditation for a media event can be found in this document or in the event-specific media advisory [here](#). IPCC Secretariat registration and accreditation system draws on the practice of the United Nations and other UN agencies.

### What must I do to become accredited at IPCC meetings?

You must register through the IPCC media registration page here: <https://apps.ipcc.ch/eventmanager/press/>

Credentials can be uploaded as PDF, JPG and PNG format. **These files should not exceed 4MB in total.**

### What is the online media accreditation form?

It allows media professionals to provide the required basic data for identification and upload the required credentials in order to be registered as media representatives to a specific IPCC event (for example, an opening session of a plenary meeting or a press conference). It also allows media professionals to request access to embargoed materials.

### Can I still apply for media accreditation as before?

Media accreditation through [this IPCC system](#) is the only official channel for media to register for IPCC events. The IPCC Secretariat will not accept accreditations via any other channel. Any accreditation materials not sent through this system will not be processed.

### I covered previous IPCC meetings. Do I have to apply again?

Yes, you have to apply. Accreditation for previous IPCC media events does not remain valid. Members of the press must be accredited for each IPCC media event. A new letter of assignment and copy of press card (or other materials in lieu of a press card) will be required each time in order to be registered and/or receive access to embargoed materials.

### I have a badge from another UN conference. Can I be approved automatically for IPCC conferences with that?

No. Press badges from other UN conferences are not valid. Members of the press must be accredited for each IPCC media event. A new letter of assignment and copy of press card (or other materials in lieu of a press card) will be required each time in order to be registered and/or receive access to embargoed materials.

### What if I am accredited to the United Nations in New York, Geneva, Vienna or Nairobi?

You still need to apply via the IPCC media accreditation system. As your credentials please simply submit a scan of your valid UN accreditation badge. Upon verifying with our colleagues in the relevant UN duty stations, we can approve your accreditation on this basis, as an alternative to a press card and letter of assignment.

### When should I accredit myself for IPCC meetings?

Accreditation will open up to one month prior to the meeting. It is strongly advised to apply for accreditation well in advance as the IPCC has limited capacity to process last minute accreditation requests and there is no guarantee that the IPCC media team will be able to review late applications. Only accredited media representatives will be provided access to the

embargoed materials and details of how to submit questions during the press conference. Currently, the deadline for media accreditations for Synthesis Report of the Sixth Assessment Report scheduled for release on 20 March 2023 is 14 March 2023.

### **What is the deadline for accreditation?**

The IPCC Secretariat will make deadline information available on the website. As a rule, however, it is highly recommended to apply as early as possible. There is no guarantee that the IPCC media team will review late applications.

### **I missed the deadline. Can I still apply?**

The IPCC Secretariat has limited capacity to deal with late applications and processing of late applications will depend on time and human resources available.

### **Is there a limit to how many media may participate in a conference?**

**Yes, a quota on the number of in-person participants may be enforced in the interest of security and safety in the case of in-person meetings. The in-person quota depends also on the physical capacity of the venue.. There is no quota for the virtual attendance.**

### **What happens when the quota is reached?**

In case of an in-person press conference, access will be possible until the capacity of the venue is reached. In general, even if the event is taking place in-person, IPCC press conferences are also streamed live. This is applicable only to in person meetings.

### **To register online, what information do I need?**

In order to complete the process, you will need the following information. All information must be entered as it appears in the passport or other official photo identification document, which the participant intends to present at the registration desk.

- Full name
- Email address
- City
- Nationality
- Scanned copies of your credentials. The system will allow 2 files maximum 4MB
- Phone number

In addition, you will need to provide your affiliation and position and indicate which events you plan to attend as well as whether you would like to access embargoed materials.

### **What do you do with this information?**

The names and information entered are for purposes of identification and verification only, and for the preparation of media badges in the case of physical meetings.

### **How do I register with the form?**

Please go to the [IPCC media registration](#) page to access the [online registration form](#), which allows you to provide your personal details and upload your credentials. On the IPCC media portal, follow the following steps:

- Click Register
- Read the pop-up message. You need to agree to proceed to the form.
- On the form, select the event;

- Select one or more of the following options: *Press Conference (online)*; *Press Conference (in-person)*; *Embargo* (check this box if you want to receive access to the embargoed materials).

Note: select the in-person options only if you will be attending these events in person.

- Fill in the rest of the form.
- Upload your credentials;
- Fill in the rest of the form;
- Click “Request Access”;
- Read information on the pop-up window and click “I agree” to submit the form.

Once your request has been processed you will receive an email with relevant details.

The confirmation e-mail to the media representatives who will opt to attend the opening ceremony and/or press conference in person, will include additional information on when and where to collect their badges allowing access to the opening ceremony and press conference venues.

If you requested materials under embargo, you will receive another email with your personal log-in details. These will take you to the page with embargoed media materials:

<https://apps.ipcc.ch/eventmanager/press/>.

If you have used the system before, the e-mail that you will receive will indicate that you should use “Your IPCC password”, which refers to your previous password. In case you have lost it, please click “Forgot password” on the IPCC media portal to reset your password.

### How do I get access to materials under embargo?

Media representatives who want access to the embargoed materials must select the option for “embargo” on the online form, regardless of whether they are registering to attend the press conference or not. You will also need to submit your credentials and agree to the IPCC embargo conditions.

### How do I get details of how to submit questions?

Media representatives who register to attend the press conference virtually will receive details on how to submit questions closer to the time of the press conference.

### How can I send my credentials to you?

Credentials should be uploaded on [the IPCC media registration pages](#) and submitted together with the online form. The system will allow two files, each not exceeding 4MB. Files can be in PDF, JPG or PNG formats.

### To whom do I address the letter of assignment?

To the IPCC Press Office ([media@ipcc.ch](mailto:media@ipcc.ch)).

### What should the letter of assignment contain?

The letter of assignment must be on letterhead and be addressed to the IPCC Press Office. It must be signed by an authorized official (e.g. the Publisher, Assignment Editor or Bureau Chief), of the media organization seeking accreditation. Unsigned letters or e-mails will not be accepted. Letters of assignment must specify the type of coverage, event or project assigned; the period of time for which accreditation is required; and the name and professional function(s) of the individual(s) to be assigned.

If you work as a photographer or as part of a TV crew you are asked also to indicate this on

the letter of assignment so that the IPCC can plan sufficient space for the conference you wish to attend in the case of an in-person meeting. Please also state any special requirements, e.g. for TV crews.

### **I don't have a press card. Will you still accredit me?**

If you don't have a press card, you will be asked to submit additional materials.

### **What do you mean by "additional materials"? What is required?**

If you are asked to submit additional materials, the materials detailed below may be requested. Please note that submitted work samples must demonstrate active engagement in covering the activities of the United Nations and/or climate issues. Samples must be unaltered clippings or media products of the bona fide media organization with bylines of the individual requesting accreditation.

- Print media representatives are required to submit two bylined articles published within the past four months and a copy of the publication. These may be scanned PDF files or links to the article online.
- Radio and TV media representatives are asked to submit two recordings of reports made within the past four months.
- Photographers are required to submit original tear sheets or photos with credits of the issuing organization. It is also possible to provide links to photos online, as long as the photo attribution is clearly that of the applicant.
- Online media must meet the following requirements (subject to all other criteria, online media may include news outlets, blogs, vlogs and others):
  - The web publication must belong to a registered media organization and have a specific, verifiable, street address and telephone number.
  - The website must have at least 60% original news content or commentary or analysis, including coverage of international or UN related issues.
  - The website must be updated at a minimum of three times a week.
  - The applicant seeking accreditation must provide the latest data on the site's visitors or other relevant material (press citations, etc.) about the outlet's audience. The applicant must have an established record of having written extensively on international or climate change issues and must present copies of three recently published articles with his/her byline.
- Communications Officers of a government or research institution with experts on the report author team and other partners organizations, are asked to submit a scanned copy of an ID from their institution confirming their position. Alternatively, they can submit a scanned copy for a business card and a general ID such as a passport or national identity card.

Please note that printed or online publications or other communications, outreach or advocacy online platforms and publications of non-governmental or non-profit organizations do not qualify for media accreditation.

### **Do I need to send a photo of myself?**

No photo is required.

### **How soon will I know whether I'm accredited?**

Please be aware that we expect to receive credentials for a large number of applicants and

there may be a delay between the time we receive your credentials and when they are matched to your application.

Every effort will be made to confirm your registration as soon as possible.

### **How can I check the status of my accreditation?**

If you need to check the status of your registration, please email [media@ipcc.ch](mailto:media@ipcc.ch).

### **What does the accreditation cover?**

Media accreditation you will receive is valid for coverage of a single specific IPCC conferences and/or for accessing material under embargo for this conference. It does not constitute an endorsement for any other purpose.

### **I would like to register as a delegate or observer and also have press accreditation. Is this possible?**

No. Double accreditation is not allowed (e.g. as press and delegate, or as press and observer). If you are already registered with a delegation or observer organization, your application for press accreditation will not be granted.

### **I am a freelance journalist. Can I still get accreditation?**

Freelance journalists are subject to the same requirements for accreditation and must complete the full process, as above. Freelance journalists, including photographers, must provide clear evidence that they are on assignment from a specific news organization or publication. A valid assignment letter from that news organization or publication is required. Photographic agencies must provide clear evidence from a client news organization or publication. You must also submit the other required documents for accreditation.

### **I'm a student. Can I get accreditation?**

Media accreditation is only for media professionals who represent a bona fide media organization.

### **I'm under 18 years of age. Can I get accreditation?**

No. Media representatives must be at least 18 years old to apply for accreditation and have an established track record of reporting.

### **What about press accreditation for blogs?**

Online media may include news outlets, blogs, vlogs and others, and must meet the following requirements, in addition to any other media accreditation requirements:

- The website must belong to a recognized media organization and have a specific, verifiable street address and telephone number;
- The website must have at least 60% original news content or commentary or analysis, including coverage of international or U.N issues;
- The applicant must have an established record of having written extensively on international or climate change issues and must present copies of three recently published articles with his/her byline;

- The website must be updated at a minimum of three times a week.

### **I am with an independent film company that is producing a documentary on climate change. Can I access the conference?**

Independent TV production companies are required to provide a letter from a broadcast organization or film distributor that has commissioned this work and has committed to air or distribute it, or from the UN partner organization that supports the production. The project should be climate change related. You must also submit the other required documents for accreditation.

### **I am a press officer at an Embassy/Permanent Mission. Do I need press accreditation to attend?**

No. Your name should be included on the official delegation list and you will be registered as a member of the delegation.

### **I am a communications officer for a UN agency or a government entity or a research institution whose experts are working on the IPCC report. Can I register for the embargoed materials?**

Yes. Select “Communications Officer” in the drop-down menu when registering. Embargoed materials are primarily for the use of media covering the report, but access may be extended to relevant bodies preparing communications activities and materials to coincide with the release of the report.

Like media representatives, you will be required when registering and when accessing materials to agree to respect the terms of the embargo. Your organization will not be eligible for future access if a leak of embargoed materials arises because you break the terms of the embargo.

The supporting materials you should upload would be a scanned ID from your institution confirming your position. Alternatively, you can submit your business card, and a general ID such as a passport or national identity card to confirm your identity.

### **I am an IPCC author of the report. Can I get the embargoed materials?**

Yes. You can register for the embargoed materials so that you have the press release and other communications materials to help you prepare for presentations. Please select IPCC Author when registering.

You must respect the terms of the embargo.

### **Can I do a blanket accreditation from my organization?**

It is not possible to give blanket press accreditation to a media organization. Instead, accreditation is granted to individuals representing bona fide media organizations, who provide the required valid documentation for accreditation.

### **What happens if I have to replace someone already accredited from my organization?**

We are aware that assignments can change at short notice. Please communicate changes in staff as soon as they are known. The applicant will have to complete the same process, but as long as they have the required valid materials, there is usually little delay in processing.

### **Do you fund journalists' participation?**

No.

### **Do you make hotel reservations for press representatives?**

No. Media representatives accredited to cover IPCC meetings are responsible for their own travel and hotel bookings. The Secretariat is not in a position to make these arrangements.

### **Will you help me get a visa?**

The IPCC Secretariat is not in a position to issue invitation letters for visa purposes. You may use the confirmation of your accreditation when making your visa application, as well as the letter of assignment from your media organization.

### **My accreditation was approved, now what?**

Once you have received confirmation of your accreditation, you will be registered for the selected event depending on what you chose.

In case of an in-person meeting, you may collect your badge on site at the registration desk at the conference venue, either on the morning of the press conference. The exact times will be indicated in the email confirming your registration to the events that you applied for. The media accreditation desk in the conference centre is not open at other times and media do not have access to the conference centre. You must present a valid photo ID with the personal details used in your registration. Your press card and letter of assignment will speed up the process.

In the case that you registered to attend the press conference virtually, you will receive details of how to submit questions.

If you registered to access embargo materials, you will receive log-in details to let you access the materials when they have been uploaded. The embargoed materials are uploaded after the Summary for Policymakers has been approved and the IPCC Session has ended. It is not possible to provide a specific time as it depends on the time the meeting finishes.

### **Can you send me my badge in advance? Or is there somewhere I can pick it up?**

For security reasons, it is not possible to send badges in advance. Badges are issued during in-person meetings and should be collected in person at the registration desk at the conference venue. This is applicable only to in person events .

### **What should I do if my badge is lost or stolen?**

If your media badge is lost or stolen, you MUST immediately report it to the IPCC Secretariat. This is applicable only to in person events.

### **Where am I allowed to go?**

In the case of in-person media event , accredited press have access to clearly designated areas in the conference venue, for those sessions that are open to the press, generally the opening session of the meeting and the final press conference. Specific information on media arrangements at conferences is provided through Media Advisories. These are issued at individual meetings and reflect arrangements as they apply to a given venue and/or set of circumstances. All accredited press accessing the conference premises must pass through security screening, including those with equipment. This is applicable only to in person meetings.

Information on media accreditation for IPCC meetings is for internal use only and confidential. The IPCC Secretariat does not publish or distribute media lists.
