Dear Mr. Mokssit:

On behalf of the Government of Mexico, I have the honour to nominate Dr. Irma Fabiola Ramírez Hernández for the position of Member of the Bureau of the Task Force on National Greenhouse Gas Inventories of the Intergovernmental Panel on Climate Change for the Seventh Assessment Cycle.

Dr. Ramírez currently serves as Director of Inventories and Projections of Greenhouse Gas Emissions, at the National Institute of Ecology and Climate Change of Mexico. In this capacity, Dr. Ramírez has been responsible of Mexico's GHG inventory, and its methodological improvements, including the application of IPCC 2006 methodologies, and 2019 Refinements. She has supported the technical work for the report of mitigation action in the Biennial Update Reports, with a special focus on the AFOLU sector. In addition, she has directed national capacity building efforts on IPCC methodologies to subnational authorities, reaching out to over 5,000 subnational actors.

In addition to her work on the GHG Inventory, Dr. Ramírez has shown tremendous leadership in assisting Mexico's policy makers to mainstream climate policy. Among her achievements, I would like to underscore her role in developing the projections and technical analysis that has been used in key policy instruments, such as the Special Program of Climate Change and Mexico's NDC.

Dr. Ramírez has extensive international experience. As a member of the Mexican delegation to the negotiations of the UNFCCC, she has been involved in the technical work for the Paris Agreement Work Programme, especially on Art. 13 Modalities and Procedures. As focal point to the Latin American GHG Inventories network, she has facilitated technical exchange with several countries, including Argentina, Chile, Colombia, Costa Rica, Cuba, Ecuador, and has served also as focal point for inventories with the United States and Canada.

Dr. Ramírez has delivered outstanding results on the improvement of Mexico's GHG Inventory and wishes to work internationally to assist the enhancement of
